Violation #54. Garbage & refuse disposal

Issues:

Three garbage containers with Flap open (two (2) garbage containers).

Close all garbage containers with open Flap (lid/up).

Corrected on Site (COS).

One garbage container missing (broken) both Flap(s) and/or Lid(s).

Replace garbage container for another one with both Flap(s) and/or Lids in good working condition.

Three (3) garbage container(s) missing drainage plug.

Provide all missing drainage plugs in each garbage container.

CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.

Violation #56. Ventilation & lighting

Issues:

Nonworking Light' Bulbs in:

1. 2-Door-In Reach Freezer (one (1) burned-out light' bulb).

Replace burned-out light' bulbs in Freezer.

Dust/dirt on Exhaust Ventilation System:

1. Laundry Room (dust/dirt one (1) exhaust ventilation system)/ (Corrected on Site/(COS).

2. Kitchen Prep Area (dust/dirt on three (3) exhaust ventilation system) (Corrected on Site (COS).

3. Mechanical fan on wall above the three (3)-sink compartments (Corrected on Site/(COS)).

Clean all exhaust ventilation system and fan.

CODE REFERENCE: 64E-11.003(6)(a). Adequate exhaust ventilation hood systems in food prep and warewashing areas shall be provided and designed. 50 foot candles shall be at surfaces where employees work with food and 20 foot candles shall be at surfaces where food is provided to consumers.
